Any existing balances on Baxter Credit Union DBA BCU loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

**Loss of Introductory APR:**

We may end your Introductory APR for purchases and balance transfers and apply the prevailing non-introductory APR if you are 60 days late in making a payment.

**For California Borrowers, the Visa Cash Rewards Signature is a secured credit card. Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings. Notwithstanding the foregoing, you acknowledge and agree that during any periods when you are a covered borrower under the Military Lending Act your credit card will be secured by any specific Pledge of Shares you grant us but will not be secured by all shares you have in any individual or joint account with the Credit Union. For clarity, you will not be deemed a covered borrower if: (i) you establish your credit card account when you are not a covered borrower; or (ii) you cease to be a covered borrower.**

**Other Fees & Disclosures:**Late Payment Fee:

\$29.00 or the amount of the required minimum payment, whichever is less, if your payment is not received by the next statement closing date. The next statement closing date varies from 4-6 days after your payment due date.

Balance Transfer Fee (Finance Charge):

3.00% of each balance transfer. However, this fee is waived on transactions posted to your account after the promotional period.

Cash Advance Fee (Finance Charge):

Either \$10.00 or 3.00% of the amount of each cash advance, whichever is greater.

Returned Payment Fee:

\$29.00 or the amount of the required minimum payment, whichever is less.

Rush Fee:

\$30.00 overnight. \$20.00 second day.

Statement Copy Fee:

\$2.00.
